第一商業銀行洛杉磯分行網路銀行使用者注意事項

Important! Please read the following message before using Internet Banking System.

重要訊息!使用網路銀行服務前,請詳閱以下資訊

While Internet Banking can bring you more convenience in terms of faster and easier access to your bank account(s), there are inherent risks that you need to be aware of. Due to the open nature of the Internet, web-based systems such as Internet Banking are inherently subject to risks such as those related to virus attacks, hacking, unauthorized access and fraudulent transactions. While we endeavor to ensure high availability of the internet banking, there may be isolated cases of data transmission interruption, slow speed, freezes etc. In such cases you may need to come to the branch to process your transaction.

當網路銀行可以讓您更加快速與容易使用銀行帳戶服務時,您必須了解 到使用網路銀行存在某些潛在的風險。由於網際網路開放的特性,因此 像網路銀行這類以網頁作為基礎的系統服務可能存有遭受病毒攻擊、駭 客行為、未經授權存取,或者是錯誤的交易紀錄;除此之外,透過網際 網路使用帳戶查詢或交易服務,也可能出現數據傳輸中斷、延遲、停頓 等情形。當網路銀行無法正常運作時,您可改至臨櫃辦理各項交易申請。

While First Commercial Bank, Ltd. (hereafter "FCB") has put in place the necessary security practices and measures to safe guard against these risks, in order to ensure the safety of Internet Banking transactions, you, as the end-user, also need to take necessary procedures to safeguard your account information.

✓ Confirm the login address and certification.

2. All data sent to and from FCB is "scrambled" and "reassembled" between FCB and your personal computer using the highest level of encryption commercially available. When your visit our e-banking site, there will be a yellow lock (like or between FCB) shows by browser. Please click it and check the certification information:

✓ Protecting Your Account

保護您的帳戶

1. Check your account and transaction history details regularly.

請定期檢查您的帳戶以及交易紀錄。

2. Under no circumstance will FCB ever send you an email asking for your personal information. You should **NOT** respond to such email or reveal your Password to anyone.

第一銀行絕對不會主動寄發電子郵件詢問您的個人資訊。若收到該類電子郵 件,您絕對不可回覆或洩您的密碼。

3. If any other people/group informs you that your personal information is leaked and need to check it with you, please call FCB in advance to confirm it.

若有第一銀行之外之第三人向您表示個人資料外洩,並表示須與您確認個人 資料 者,請先依本行提供之分行電話或服務專線向本行求證,以免因此洩漏 您的個人資料。

4. Do not use shared/public PCs for Internet Banking.

使用網路銀行時,請避免使用分享/公用電腦登入。

5. Please logoff the Internet Banking System after you have completed your session to avoid misuse of your account.

服務使用完畢時,請務必登出網路銀行服務,避免帳戶遭受誤用。

✓ Protect Your Password

保護您的密碼

1. Please set your Password under the following guidelines:

請依照以下規定設定使用的密碼:

(1) Make sure your Password has a certain level of complexity. The length must be 8 to 12 characters and must be a combination of alpha and numeric characters, and have at least 2 letters and 2 numbers.

密碼之設計請儘可能具有一定之複雜度,密碼長度請多於8至12碼,並 為英文、數字混雜,且至少需有2個英文字母及2個數字。

(2) Do not choose a Password that is easily guessed, like your telephone number, date of birth, User name, or other associated data.

請避免使用過於容易猜測的密碼,例如您的電話號碼、生日、使用者代號,或者是 其他相關的資料。

- (3) Never use the same Password for other financial or non-financial services. 請避免與其他財務或非財務性的使用同樣的密碼 。
- (4) Avoid using sequential numbers or the same letter or number more than twice.

請避免使用具有序列性的編號(如流水編號)或者是連續使用兩碼以上相同的文字或數字。

2. Avoid saving Customer ID, User name and Password to your Brower.

請勿設定自動儲存使用者帳號、使用者代號與密碼。

3. Do not reveal your Password to anyone or share your Password with others. 請勿將您的密碼暴露於他人或與他人分享。

4. Memorize your Password. Do not write down your Password or store it in computer hard disk, diskette, mobile phone or other insecure means.

請記住您的密碼。請勿將您的密碼寫下或儲存於硬碟、軟碟、手機或以其他不安全的方式儲存。

5. Do not use your Password when someone else can see you keying it in. 請避免在其他人可看見您鍵入的字母時,使用您的密碼。

6. Change your Password regularly by using the "Change Password" service. 請透過變更密碼功能,定期變更密碼。

7. Change your Password immediately if you suspect it has been exposed to others or the moment you suspect any unauthorized access.

若發現密碼可能已經暴露於其他人所知或者是您發現已經有未經您授權的 存取紀錄時, 請立即變更您的密碼。

✓ Protecting Your Computer

保護您的電腦

1. Protect your PC from viruses and malicious programs.

請保護您的個人電腦,避免病毒或惡意程式入侵。

2. Install antivirus software and update it with the latest virus definitions.

請安裝防毒軟體,並隨時將病毒定義檔更新至最新狀態。

3. Do not open email attachments from unknown senders, install software or run programs of an unknown origin.

請勿開啟由陌生人所寄送的電子郵件附件檔、安裝來源不明的軟體或程式。

✓ Alert Bank Officers Immediately If Any Warning Signs are Visible

若有任何可疑跡象,請立即通知本行

1. Inability to log into Online Banking.

無法登入網銀。

2. Dramatic loss of computer speed.

電腦速度驟降。

3. Changes in the way things appear on the screen.

連結網銀之畫面異常。

4. Computer locks up so the user is unable to perform any functions.

電腦遭受外部控制,無法自行操作。

5. Unexpected rebooting or restarting of the computer.

電腦非預期地重新啟動或開機。

6. Unexpected request for a Password in the middle of an online session.

非預期地要求輸入密碼。

7. Unusual pop-up messages, especially a message in the middle of a session that says the connection to FCB system is not working (system unavailable, down for maintenance, etc.).

8. New or unexpected toolbars and/or icons.

9. Inability to shut down or restart the computer.

 - (2) Internet Explorer 9 and higher, Firefox, Google Chrome, Mac Safari
